No late bids will be accepted.

It must therefore be understood that only bids from suppliers registered on the Municipality's Supplier Database or bids accompanied by a completed **Supplier Registration Application Form** will be considered. The submissions of valid up to date SARS tax clearance certificates are compulsory.
